
I am directed to refer to the subject cited and to state that “Shiv Sena” a recognized party in the State of Maharashtra, having reserved symbol ‘**Bow and Arrow**’, in that state, has requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol ‘**Bow and Arrow**’ to the candidates being set up by the said party at the current general election in the Constituencies mentioned in below table:-

2. The Commission has decided to extend the concession sought by the party under paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968. Accordingly, the candidate set up by " **Shiv Sena**" shall be allotted the symbol '**Bow and Arrow**' in the States mentioned in the table given in Para 1 above.

The Returning Officers may be informed that the candidates set up by " **Shiv Sena** " in the aforesaid Constituencies are eligible for the allotment of the symbol '**Bow and Arrow**' under paragraph 10 of the Symbols Order, 1968 subject to strict fulfillment of each of the provisions of paragraph 13 thereof.
